## Tuition and Continuous Enrollment Agreement 2023-2024

### Tuition and Enrollment Terms

1. There is a one-time registration fee of \$100 per student for K-12 enrollments (maximum \$200 per family per school year) and \$50 per student per year for Preschool and Junior Kindergarten enrollments. Upon acceptance of enrollment, the registration charge will be added to the family's FACTS account and is expected to be paid within 20 days.
2. The payment in full of any prior commitment is required by July 31. If unable to obtain funds for payment of the total prior balance, I/we will meet with the Grandville Calvin Christian Schools (GCCS) Finance Team before July 31; otherwise, my/our child(ren) will not be admitted to school at the beginning of the school year. Any previously paid enrollment fee will be applied toward any prior balance if my/our child(ren) does (do) not attend school this fall. A time/price differential of 1.5 percent per month will apply to the prior year's balance, beginning September 1. A separate account will be established for prior unpaid tuition. For each month the required monthly payment is received by the tenth of the month, the time/price differential will be waived for that month.
3. A fee of \$30 is charged to my/our account for any check issued by me/us with insufficient funds.
4. I/We understand that the total cost of education and my commitment may be adjusted upward or downward based on actual enrollment and any adjustments made to tuition rates.
5. I/We understand that the rules of the Michigan High School Athletic Association forbid students to participate in a team sport or try out unless formally enrolled. Coaches are not permitted to make exceptions.
6. I/We understand that if I/we do not meet the above terms, GCCS may take one or more of the following steps: communicate with my church; remove my/our student(s) from the school and/or refuse to allow my/our student(s) to begin the next school year; initiate legal action to collect tuition due. I/We agree to this tuition payment schedule unless I/we reach a special written agreement with the GCCS Finance Team. I/We agree to pay all costs of collection and actual attorneys fees and costs incurred by GCCS as a result of any failure to pay tuition as due. I/we further agree that this agreement shall be governed by the laws of the State of Michigan. I/we agree that any legal action brought against me/us based upon this agreement shall be brought in the state or federal courts of Grand Rapids, Kent County, Michigan. I/we also waive the right to a trial by jury in any lawsuit for any issues involved in this contract.

- A 1% discount will be applied to your tuition account if payment in full is received by August 15 prior to the start of the school year.

**Continuous Enrollment for Kindergarten through 12th grade**

I/We understand and agree that I/we are enrolling my/our child until 12th grade graduation, on a continuous basis, unless I/we or the school decide to end this partnership. If I/we decide to end the partnership, I/we must notify the GCCS Business Office by the withdrawal date of April 30 prior to the start of the new school year. Continuous Enrollment means that the undersigned agrees to all the tuition and enrollment terms outlined in paragraphs 1-6 above for each consecutive year a child is enrolled.

I/We understand and agree that failure to notify GCCS of withdrawal by April 30 prior to the start of the next school year will result in a 10% charge of the upcoming school year tuition rates.
